

The United Nations definition of Climate Justice

"Climate justice advocates for equitable solutions that prioritise the needs of those who are most affected by climate change, strive to reduce greenhouse gas emissions, and ensure that the burdens and benefits of climate action are distributed fairly, taking into account historical and systemic inequalities."



Climate Justice

Recalls the human rights to safe drinking water and sanitation

Focus #1 Accessible

All women and girls must have equal access quality education Living in a family, community or nation where there are **gender norms and bias** intersecting with the failure to allow women or girls to have a quality education

Living in a country, region or community where there are **insufficient budget allocations** to provide everyone with a quality education or **gender norms and bias intersect** with **allowing a budget** that includes **gender equality** issues in education

Belongs to a marginalised group: poverty, rural, remote, indigenous, humanitarian and fragile contexts, national or ethnic, religious and linguistic minorities women and girls with disabilities, older women, LGBTQ+



Focus #2 Availability

Education must be available on a lifelong basis via infrastructures which are available, safe and healthy and of good quality

Shortage of schools: Needed to ensure that educational infrastructures were either rebuilt or created which were safe and provided a healthy environment for female students and teachers to attend and travel to and from

Shortage of teachers: Female teachers are fundamental to ensuring every aspect of quality education. At present there is a shortage of female teachers. The higher one goes in the educational system the higher the shortage of teachers including in STEM (science, technology, engineering and math)

Must provide **training** and employment of appropriately qualified teachers for quality inclusive education and training which includes digital technology at all levels.

The feminised nature of the education and training is preventing female teachers from creating curricula or career counseling which provides digital and climate literacy as they are **not being provided** with continual training and skills in these areas or in the area of critical thinking or technology or new and relevant tools (internet, electronic devices and connections e.g.) which would support such a goal.

The female imbalance or occupation segregation in teachers' professions or female student's choice of employment in STEM or emerging fields.

Other obstacles which still exist in providing quality education and training under certain circumstances:

- girls including during and after conflicts famine or natural to those who are **disabled** or live in **remote** or **rural** areas
- How to provide for need of **multilingual language** •



How to provide a quality and culturally diverse education to women or disasters, humanitarian events, displacement migration, pandemics or

Focus #3 Education must be available on a lifelong basis

In the age of digital technology, we must focus on providing lifelong education which is relevant and deals with emerging subjects and careers all of which will enable all women and girls to get the necessary education and training needed to be employed in decent work

And for them to be able to be among those who control technology and their choices of decent work rather than be controlled by technology and the choice of what employment - if any- is available to them

Advocate for improved access to electronic devices and connections for

Support grassroots education & training programmes especially for digital

Promote the training and employment of appropriately qualified teachers

for quality inclusive education and training including **digital** technology at all levels, especially for continuing and non-formal education

Advocate for Member States to raise awareness regarding the barriers in employment such as lack of access to **progressive training** programmes and

Encourage national Governments to provide through life, women and girls with equal access and support to quality learning opportunities in science, technology, engineering and mathematics(**STEM**) subjects which are

CSW 68: Interdependence with poverty

- Access to basic quality healthcare, hygiene, sanitation, and safe water
- Availability of critical health services and education must be made available to all women and girls
- Adopt inclusive, universal healthcare via increased investments in quality healthcare provisions, staffing, training, and community education programmes
- Promotion of healthy ageing across the life course for all women and girls
- Universal access to sexual and reproductive health and rights
- Human rights-based approach to all policies, legislation, discussions, and decisions related to all aspects of health for all women and girls



Action

Gather, request, receive and exchange right-to-health information from all relevant sources

Maintain dialogue and discuss possible cooperation with all relevant actors, including local and national Governments, United Nations bodies, specialised agencies as well as NGOs

Report on the status throughout the world of the right to health, including laws, policies, good practices and obstacles

Recommend appropriate measures that promote and protect the right to health

Promote education programs about health care including sexual and reproductive health

Advocate for gender related financing for all health care programs

Be involved in draft of the next CSW session on national level (this will be CSW69 in 2025)
